## A Simple Two Step Plan

The Kick Them All Out Project is a simple two-step plan to SERIOUSLY begin the process of ending corporate special interest corruption in our government and election process.

**Step 1:** Right now, most of our representatives in Congress think everything is fine exactly the way it is. They pay lip service to the corruption, but most are completely complicit in the corruption. So the first order of business needs to be doing what we have to in order to fill the Congress with people that actually have an interest in cleaning up all the corruption.

We can do this by simply firing every single incumbent in a landslide election. If you're a staunch republican, vote for any other republican other than the incumbent. If you're a staunch Democrat, vote for any other democrat than the incumbent. If you don't belong to any party, just vote for anybody other than the incumbents. (If this way of dealing with the problem makes you uncomfortable, please see the FAQ section that addresses most all the fears and objections people have raised).

By doing this simple task, in a totally committed way, we can impose our undeniable will over our representatives and establish once and for all, we control their jobs, not special interest groups or the political parties they control. If we do this just once, we will prove we are willing and capable of doing it, which will give new meaning to "the will of the people."

Until we do this, nobody is going to pay any attention to us. Once we have their attention, we can demand they do what's necessary to start the process of closing the legal loopholes corporations have used to take over our government and elections. Once we have their attention, we can set the mandate to accomplish Step 2 within their first year in office. If they don't, we let them all know they are going to ALL be fired in the next election. We do this until we get Step 2 accomplished.

**Step Two:** Creating the legal framework necessary to revoke the human rights protections corporations have been claiming by distorting the meaning and intent of the 14th Amendment. This one legal contrivance lies at the heart of why corporate special interests are allowed to directly interfere in government and elections. By closing this tiny loophole, we can literally defang corporate power over our lives and our government and shift the balance of power back to our side of the equation.

The good news is it's very, very simple. All we need to do is submit an amendment to the Constitution that clarifies the true intent and meaning of the 14th Amendment.

### **Fourteenth Amendment**

**Section. 1. ALL PERSONS** born or naturalized in the United States and subject to the jurisdiction thereof are citizens of the United States and of the State wherein they reside. No State shall make or enforce any law that shall abridge the privileges or immunities of citizens of the United States; nor shall any State deprive any person of life, liberty, or property, without due process of law; nor deny to any person within its jurisdiction the equal protection of the laws.

We are not talking about creating a whole new amendment. All we need is an amendment that clarifies an existing amendment. Then, all we need to do is put enough pressure on our representative and DEMAND they pass it and put the required pressure on our state representatives to ratify it. This Amendment is literally the key to the REAL beginning of the end of corporate control over our government, elections and our lives.

Below is an example of the kind of simple resolution that will be required to add the necessary amendment to the Constitution. The following amendment will close the legal doors on the largest problem this nation faces. I can't emphasize strongly enough the importance of getting an amendment like this ratified. It is the ONLY thing that will allow us to legally get corporate control out of our government and political process.

Amending the constitution is a Constitutional process. It was established to ensure the Constitution remains relevant to the circumstance and needs of the times. And the time for this kind of amendment is way past due! If you want to end the primary source of all major corruption, we must demand this amendment be added to the Constitution as quickly as possible. The bottom line is we cannot get corporate money and their lobbyists out of the system until we close this loophole. It's absolutely essential.

So the big question is, do you want business-as-usual to change in government or not? If you do, these are the first "specific" steps we must take.

### JOINT RESOLUTION

Proposing an amendment to the Constitution of the United States that will clarify the true meaning and intent of the 14<sup>th</sup> Amendment so that the ambiguous language can no longer be exploited to provide the unintended benefits of human rights protections for corporations.

Resolved by the Senate and House of Representatives of the United States of America in Congress assembled, That the following article is proposed as an amendment to the Constitution of the United States, which shall be valid to all intents and purposes as part of the Constitution when ratified by the legislatures of three-fourths of the several States within seven years after the date of its submission for ratification:

**`Article –**

`Section 1. The words “All Persons” written in the 14<sup>th</sup> Amendment refers specifically to “natural persons,” individual, living, breathing, human beings, regardless of gender, race, color, or religious beliefs, that are legal United States citizens.

`Section 2. After the date of the ratification of this article, the words “All Persons” written in the 14<sup>th</sup> Amendment will no longer pertain to or include the legal fiction of “corporate personhood.” Further, after the date of the ratification of this article, all human rights protections previously claimed by artificial corporate entities shall be permanently unrecognized and revoked.

`Section 3. The Congress shall have power to enforce this article by appropriate legislation.'

Getting this amendment on the books is essential if you really want to end the reign of corporate colonialism that is swallowing up this world. We can throw a major wrench into the global machine with this one simple piece of legislation. Our country still is the beacon to the rest of world. If we turn things around here, the rest of the world will follow. If we don't, the rest of the world is doomed.

Once this amendment is in place, we can than move to take the machine apart, starting with the global elite's primary source of power, their total control of our currency and credit system through their private central bank, the Federal Reserve, and abolish the insane "fractional reserve banking scheme" that allows these people to claim they have money they don't actually have. They just get to say they do. If a banker has \$1000 on hand, they get to say they have \$10,000 and lend out \$9,000 and charge you interest on it by simply making journal entries. This is where most all the inflation comes from and why those with the most wealth and power have it. If you did that with your checking account, how long would you stay out of jail? Well, these s.o.b.s get away with it on a massive scale every day of the week for centuries.
